Student membership will have golf privileges only and will not be able to charge.

Golf Course Rules

All rules stated herein apply to both members and non-members alike!

All members except Social Members (ten 18-hole rounds per year) are entitled to unlimited green fees.

The Board in accordance with the by-laws may modify the green fee rates.

All players must register in the golf Shop prior to teeing off. USGA rules will govern play.

Proper golf attire must be worn at all times on any part of the golf course and driving range. Proper golf attire will be determined at the discretion of the Pro Shop.

Starting on any hole other than the designated first hole will not be permitted unless the golf shop or starter gives permission.

Animals or pets will be prohibited from all Olive Glenn golf course property (golf course itself, parking lot, clubhouse and patio areas, putting green & driving range areas and other lawn areas around clubhouse). Animals or pets will be permitted on the service road network through or adjacent to the golf course.

No more than four players will be permitted in each group. Group of five or larger will be allowed only with special permission from the golf shop.

Threesomes and Foursomes have priority over twosomes and singles. Prior to play, the golf shop will pair singles and twosomes if the conditions so warrant.

Anytime one full hole is open ahead of any group, the players following that group shall be allowed to play through.

Players are required to replace all divots including those taken on the tee, repair all ball marks and rake all bunkers leaving the rake inside the bunker.

Motorized golf carts and push carts shall obey all posted signs and directives. Motorized carts must remain a minimum of 30 feet from all greens and preferably on the cart paths. No motorized cart of any kind will be allowed on the tee at any time. Children under the age of 16 shall not operate a golf cart. Cart driver must have a valid driver's license.

Golf carts must be returned to Golf Pro Shop by a time to be designated by Pro Shop. If not returned by this time, an additional rental fee will be charged.

Use of shoes with metal spikes are prohibited on the golf course or in the club house. High heels or rubber cleats (Football/Baseball type shoes) will not be permitted on the golf course.

All food and beverages must be purchased from the Stampede Bar and Grill unless special arrangements have been made with the Stampede Bar and Grill Manager.

Players are expected to play nine holes in two hours and fifteen minutes or less.

Players taking a break after nine holes will lose their designated 10th tee priority.

House Rules

The Stampede Bar and Grill will be under the direct supervision of the Stampede Bar and Grill Manager Lessee, whose authority over the restaurant areas and food/beverage matters will be final until/or unless countermanded by the Board of Directors.

Use of Pioneer Room and Stampede Bar and Grill will be at the discretion of Stampede Bar and Grill Manager Lessee. There is no cost for use of Pioneer Room/Stampede Bar and Grill areas for members. Nonmember rental fee will be at the discretion of the leasing manager.

In the event of a disagreement between members and/or employees, a Board Member should be notified. If the disagreement cannot be resolved, a written request may be made to the Board of Directors.

None of the Club's property shall be rented or loaned without consent of the Board of Directors.

Notices, subscriptions, papers or petitions shall not be posted or circulated unless they relate to Club affairs and with consent of Board of Directors.

No list of members and their mailing addresses shall be given out to non-members for any purpose.

All members and their guests as they relate to the sales of liquor shall strictly adhere to the laws of the State of Wyoming.

Due to emergency vehicle access, no parking shall be permitted on any part of the entrance driveway other than those allowed to park in the handicapped parking area.

Golf Simulator Rules

The Golf Simulator is for the use of the Olive Glenn Members. Olive Glenn members may bring guests based on the following criteria:

- Members with a corresponding membership level of Blue or Gold are free of charge.
- Student membership and nonmember guests shall pay a fee of \$20.00/hour per person.
- Reservations are required per signup sheet and limited to a two-hour time slot.
- Non-members may play with a fee of \$20.00/ hour. Reservations required per sign up sheet, limited to a two-hour time slot.

Golf Simulator Etiquette

Players should ensure that no one is standing nearby or in a position to be hit by the club or the ball.

Players should always show consideration for other players.

Players should play at a good pace and remember they are playing and paying by the hour.

Players should be ready to play as soon as it is their turn to play.

Players should avoid causing damage to the simulator by taking unnecessary practice swings or slamming the floor in anger.

Throwing clubs is strictly prohibited.

Weight and Fitness Room

All member users must obtain a key from the Olive Glenn Business Office, to be registered in their name only. No duplicates of such keys shall be made.

Only members of Olive Glenn Golf and Country Club and their guests of which both need to be 13 years or older will be allowed unsupervised use of this room.

Hours of operation will be daily 5:00 AM – 9:00 PM seven days a week.

No food will be allowed in the weight/fitness room. Beverages are allowed in a non - breakable container.

Please turn off the lights, TV, organize the free weights, dumbbells, and generally assist in keeping our weight/fitness room in an orderly and clean fashion when finished using the room.

Overall Responsibility and Liability

Members will be held personally responsible for the removal of or damage to club property by themselves, members of their family or guests. The Club is not responsible for the loss or damage to personal property left in the Clubhouse or on the Club property.

If a member, a family member, or guest of the member is guilty of a rule and regulation infraction, the following disciplinary action will be taken:

First Offense: will involve a warning and/or an immediate expulsion from the facility and a written letter of the rules violation by the Board of Directors will be sent to the member.

Second Offense: will be a suspension of the use for the member of the particular area where the violation occurred. The Board of Directors will send a written letter of suspension to the member.

Third Offense: will involve a personal appearance to the Board of Directors. The Board of Directors will decide on a disciplinary action at that time.

Board of Directors encourages membership to attend monthly board meetings.

The Board of Directors may add to, modify or change the Rules and Regulations of the Club at any time. Changes will be passed along to members via email correspondence.
